What is the organization's primary exempt purpose?  
 To assist families and individuals with limited resources in accessing New York City public burial records, provide information concerning city burial procedures on Hart Island, advocate for ending mass burials in New York City and preserve Hart Island as the largest natural burial ground in the United States. We provide free access to an on-line database of mass burials with navigation, augmented reality grave marking, interpretive guide, landscape visualization as well as custom searches, personal assistance and support for creative projects about Hart Island.

**28** The Hart Island Project collaborated with researchers in landscape architecture at Ohio State University on a landscape strategy for ending mass burials and preserving City Cemetery as the largest municipal cemetery and green burial ground in the United States. The Hart Island Project collected 360 images across the landscape and developed software to show how the landscape would appear at those locations in the future.

**29** The Hart Island Project assisted families on gaining information about city and conducting gravesite visits. The Hart Island Project conducted presentations on Zoom throughout 2024 explaining the city's historic burial practice and a proof of concept for ending mass burials. The Hart Island Project hosted a table at Bronx Parks Speak-up and introduced a landscape strategy for ending mass burials. The Hart Island Project collaborated with the Mayor's Office of Faith-Based and Community Partnerships to communicate a strategy to end mass burials in New York City. The Hart Island Project worked with the Nation and WNYC public radio on "Blindspot" podcast about the early days of the AIDS Epidemic. The Hart Island Project reviewed historic burial ledgers at the NYC Municipal Archives to confirm when New York City began to reuse burial plots and for consistency of the burial process.
