THE ALLEY/"THE ALLEY SESSIONS" A ONCE RUN-DOWN HISTORIC ALLEY WAS TRANSFORMED INTO A VIBRANT ARTS CORRIDOR AND COMMUNITY GATHERING SPACE OPEN TO THE PUBLIC FOR A FREE, FOUR CONCERT SERIES (ARTISTS WERE PAID A COMPETITIVE MARKET RATE), SERVING 1,310.
