ICWC STRIVES TO PROVIDE SECURITY AND STABILITY FOR CHILDREN WHO (CONTINUED SCH. O) ARE ABUSED, ABANDONED OR NEGLECTED AND FOR IMMIGRANTS WHO ARE VICTIMS OF DOMESTIC VIOLENCE.

THIS LEGAL ASSISTANCE INCLUDES DIRECT LEGAL REPRESENTATION FOR IMMIGRANT SURVIVORS, AS WELL AS THE OPERATION OF ORIENTATION PROGRAMS AND INFORMATION SESSIONS FOR IMMIGRANTS WHO MUST REPRESENT THEMSELVES IN IMMIGRATION COURT. ICWC SPECIALIZES IN AFFIRMATIVE IMMIGRATION REMEDIES SUCH AS U-VISAS, AND VIOLENCE AGAINST WOMEN ACT (VAWA) PETITIONS. ICWC ALSO HAS A STRONG FOCUS ON PROVIDING ASSISTANCE TO UNACCOMPANIED CHILDREN INCLUDING SPECIAL IMMIGRANT JUVENILE STATUS (SIJS) AND ASYLUM SERVICES. IN 2024, ICWC PROVIDED DIRECT LEGAL SERVICES TO OVER 16,750 INDIVIDUALS.
