OUR STUDENTS ATTEND SCHOOL DAILY FROM 800 A.M. UNTIL 500 P.M. EACH DAY. THE FOLLOWING IS A BRIEF OUTLINE OF OUR EXTENDED DAY EACH CONTENT-AREA CLASS IS SCHEDULED FOR 60 TO 90 MINUTES EACH DAY.
