AS A LEADING ADVOCATE FOR ANIMALS IN OUR COMMUNITY, MCHA CONTINUES TO CHAMPION THE RIGHTS AND WELLBEING OF PETS AND THE PEOPLE WHO LOVE THEM. IN 2024, THROUGH OUR NONPROFIT VETERINARY CLINIC, MCHA PROVIDED MORE THAN 134,000 IN FREE VETERINARY CARE TO PETS IN NEED - ENSURING FAMILIES WITH LIMITED FINANCIAL RESOURCES COULD ACCESS ESSENTIAL SERVICES FOR THEIR ANIMALS.

OUR PET FOOD PANTRY DISTRIBUTED 28,138 POUNDS OF PET FOOD TO HUNGRY PETS. WE PROVIDED 1,450 DAYS OF CRISIS HOUSING FOR PETS WHOSE OWNERS WERE IN TEMPORARY CRISIS, ENSURING THEY REMAINED SAFE AND CARED FOR.
