JCUA's commitment to combatting racism and antisemitism are priorities within this work.

Youth Engagement: The Or Tzedek Teen Internship and College-aged Fellowship year-long programs train youth in the JCUA model of addressing systemic issues of inequality from a root-cause approach; strengthening civic engagement as a core aspect of Jewish identity; and providing youth with community-organizing skills. Through the programs, youth deepen their identities as compassionate and civically engaged leaders.

Community Investment: JCUA's Community Ventures Program provides zero-interest pre-development loans for affordable housing, economic development, and job creation projects across this city. Individuals and institutions participate in this program through granted and loaned funds to the revolving loan fund. JCUA has adopted the requirements for accounting for uncertain tax positions and management has determined that JCUA was not required to record a liability related to uncertain tax positions as of December 31, 2024 and 2023.
