MANY FAMILIES STRUGGLE TO PAY FOR BASIC NEEDS LIKE ELECTRICITY AND GAS, AND MANY PUBLIC SCHOOL DISTRICTS FACE BUDGET CUTS THAT AFFECT EDUCATIONAL QUALITY.
