THE NORTHEAST ENTREPRENEUR FUND (EF) PROVIDES SMALL BUSINESS SERVICES AND LOANS TO BUSINESS OWNERS AND ASPIRING ENTREPRENEURS IN ITS 29 COUNTY SERVICE AREA OF MINNESOTA AND WISCONSIN. IN 2024, TOTAL PROGRAM COSTS OF \$12,502,694 WERE EXPENSED TO PROVIDE SERVICES TO 1,856 ENTREPRENEURS. 164 LOANS WERE DISBURSED TO THOSE CLIENTS TO START,STABILIZE OR EXPAND THEIR BUSINESSES. A TOTAL OF \$11.1 MILLION IN LOANS WERE APPROVED. A MAJORITY OF THOSE WERE DISBURSED TO LOW-INCOME INDIVIDUALS OR IN LOW-INCOME COMMUNITIES. EF TARGETS AND SERVES UNDERSERVED BUSINESS OWNERS AND RURAL COMMUNITIES.
