RESEARCH - OUR EFFORTS TO AMPLIFY THE NEEDS OF AAPI WOMEN IN THE POLICY AND ADVOCACY SPACE REQUIRE THAT WE SHARE DATA WHICH HIGHLIGHT THEIR UNIQUE EXPERIENCES AND PROVIDE THE EVIDENCE NECESSARY TO ADVOCATE FOR SYSTEMIC CHANGES. TO THIS EFFECT, ONE OF THE GREATEST CHALLENGES WE FACE IS THE LACK OF REPRESENTATIVE AND DISAGGREGATED DATA FOR AAPIS ON TOPICS RANGING FROM HEALTHCARE ACCESS TO PAY PARITY. BECAUSE OF THIS GAPING HOLE IN RESEARCH ON THE FASTEST GROWING RACIAL GROUP IN THE US, NAPAWF HAS NEEDED TO CONDUCT ITS OWN RESEARCH TO PROVIDE DATA TO SUPPORT OUR POLICY, ADVOCACY, AND COMMUNITY ORGANIZING. WE ALSO WORK WITH OUR MEMBERS ON THE GROUND IN OUR ANALYSIS OF THEIR LIVED EXPERIENCES, INFORM THEM OF ISSUES, AND UTILIZE THEIR BASE NETWORKS TO DISSEMINATE MESSAGES AND EDUCATION.
