RONALD MCDONALD HOUSE CHARITIES OF ANN ARBOR OPERATES TWO HOUSES (THE MAIN HOUSE AND MOTT HOUSE) THAT PROVIDE UP TO 43 FAMILIES EACH NIGHT WITH A SAFE AND COMFORTING "HOME AWAY FROM HOME" WHILE THEIR CHILD IS RECEIVING TREATMENT AT LOCAL HOSPITALS. FAMILIES RECEIVE A PRIVATE ROOM AND BATHROOM, ACCESS TO COMMON AREAS, KITCHEN, LAUNDRY, AS WELL AS HOME COOKED MEALS. NO FAMILY IS EVER CHARGED FOR THEIR STAY, SOME LASTING MONTHS. IN 2024 THERE WERE 436 FAMILY STAYS WITH AN AVERAGE STAY OF 36 NIGHTS. 1,278 INDIVIDUAL MEALS WERE SERVED AND 4,700 FAMILIES WERE SERVED BY OUR HOSPITALITY CARTS LOCATED IN THE HOSPITAL.
