Through these programs we cleared over \$7,000 in legal debt related to Class C fines & fees.* We helped file bills supporting fines and fees relief, criminal record clearing, client visitation for indigent defendants, and open courts in the states 88th Interim Legislative Session.* We participated in a coalition working to repeal the Failure to Appear/Failure to Pay Program across Texas.* Our Systemic Litigation team maintained 5 major lawsuits, including litigation to end over-detention, to open courts to the press and public, and to guarantee timely appointment of quality counsel for all.
