IN 2024: 85 INDIVIDUALS RECEIVED PROTECTIVE PAYEE AND FINANCIAL MANAGEMENT SERVICES.HOP DELIVERS PERSON-CENTERED, HOUSING-FOCUSED OUTREACH TO INDIVIDUALS WITH MENTAL ILLNESS AND OTHER DISABILITIES WHO ARE LIVING UNSHELTERED. ADVOCATES ASSESS CLIENTS AND HELP STABILIZE THEIR HEALTH AND HOUSING SITUATIONS.
