AS THE SOLE PROVIDER OF DOMESTIC VIOLENCE SHELTER SERVICES AND PARENTING TIME CENTER SERVICES IN REGION 5+, MID-MINNESOTA WOMEN'S CENTER (MMWC) DBA RELATIONSHIP SAFETY ALLIANCE (RSA) SERVES AS A VITAL RESOURCE FOR VICTIMS/SURVIVORS. INNOVATION REMAINS CENTRAL TO OUR MISSION AS WE ADAPT TO MEET THE EVOLVING NEEDS OF OUR COMMUNITY. IN NOVEMBER 2023, WE EXPANDED PARENTING TIME CENTER SERVICES BY INTRODUCING THE NURTURING PARENTING SKILLS CURRICULUM, WHICH TEACHES PARENTING TECHNIQUES DURING SUPERVISED VISITS. ADDITIONALLY, RSA PARTNERED WITH THE CROW WING COUNTY COMMUNITY CORRECTIONS DEPARTMENT TO CO-FACILITATE THE MEN'S NONVIOLENCE PROGRAM FOR INDIVIDUALS CONVICTED OF QUALIFYING DOMESTIC VIOLENCE OFFENSES. IN APRIL 2024, WE LAUNCHED A NEW COMMUNITY PARENTING PROGRAM, LOVE AND LOGIC, DESIGNED TO HELP CAREGIVERS BUILD HEALTHY RELATIONSHIPS WITH CHILDREN WHILE ADDRESSING PROBLEM BEHAVIORS. WE ALSO IMPLEMENTED MULTIPLE NEW "SHELTER CLINICS," ENABLING RESIDENTS AND NON-RESIDENTS TO ACCESS VALUABLE RESOURCES WITHOUT ADDITIONAL BARRIERS. RSA CONTINUES TO BENEFIT FROM RENEWED INTEREST IN INTERNSHIPS FROM COLLEGE STUDENTS, ENHANCING OUR CAPACITY TO SERVE THE COMMUNITY. ANOTHER SIGNIFICANT SUCCESS IS OUR RETURN TO LOCAL SCHOOL CLASSROOMS, WHERE WE PRESENT ON TOPICS SUCH AS BULLYING, HEALTHY RELATIONSHIPS, AND AVAILABLE RESOURCES. IN AUGUST 2024, RSA WAS HONORED TO BE VOTED THE 1 BEST NONPROFIT FOR THE SECOND CONSECUTIVE YEAR AND 2ND PLACE FOR BEST SMALL COMPANY TO WORK FOR (LESS THAN 50 EMPLOYEES) IN THE BRAINERD DISPATCH'S 2024 CONTEST. LAST FISCAL YEAR, OUR SHELTER PROVIDED CRITICAL ASSISTANCE TO 932 INDIVIDUALS, INCLUDING 145 RESIDENTS AND 567 NON-RESIDENTS. AMONG THE RESIDENTS, 55 WERE CHILDREN, AND THE SHELTER PROVIDED A TOTAL OF 3,365 BED NIGHTS. AT THE ALEX & BRANDON CHILD SAFETY CENTER, WE SERVED CLIENTS FROM 15 DIFFERENT COUNTIES, FACILITATING 1,081 VISITS, 310 EXCHANGES, AND COMPLETING 226 NEW INTAKES. ADDITIONALLY, MMWC/RSA CONDUCTED 348 GROUPS AND REACHED 5,556 INDIVIDUALS THROUGH PRESENTATIONS AND GROUP SESSIONS, FURTHERING OUR MISSION TO CREATE SAFER, HEALTHIER COMMUNITIES.

ADDITIONALLY, RSA PARTNERED WITH THE CROW WING COUNTY COMMUNITY CORRECTIONS DEPARTMENT TO CO-FACILITATE THE MEN'S NONVIOLENCE PROGRAM FOR INDIVIDUALS CONVICTED OF QUALIFYING DOMESTIC VIOLENCE OFFENSES. IN APRIL 2024, WE LAUNCHED A NEW COMMUNITY PARENTING PROGRAM, LOVE AND LOGIC, DESIGNED TO HELP CAREGIVERS BUILD HEALTHY RELATIONSHIPS WITH CHILDREN WHILE ADDRESSING PROBLEM BEHAVIORS. WE ALSO IMPLEMENTED MULTIPLE NEW "SHELTER CLINICS," ENABLING RESIDENTS AND NON-RESIDENTS TO ACCESS VALUABLE RESOURCES WITHOUT ADDITIONAL BARRIERS. RSA CONTINUES TO BENEFIT FROM RENEWED INTEREST IN INTERNSHIPS FROM COLLEGE STUDENTS, ENHANCING OUR CAPACITY TO SERVE THE COMMUNITY. ANOTHER SIGNIFICANT SUCCESS IS OUR RETURN TO LOCAL SCHOOL CLASSROOMS, WHERE WE PRESENT ON TOPICS SUCH AS BULLYING, HEALTHY RELATIONSHIPS, AND AVAILABLE RESOURCES. IN AUGUST 2024, RSA WAS HONORED TO BE VOTED THE 1 BEST NONPROFIT FOR THE SECOND CONSECUTIVE YEAR AND 2ND PLACE FOR BEST SMALL COMPANY TO WORK FOR (LESS THAN 50 EMPLOYEES) IN THE BRAINERD DISPATCH'S 2024 CONTEST. LAST FISCAL YEAR, OUR SHELTER PROVIDED CRITICAL ASSISTANCE TO 932 INDIVIDUALS, INCLUDING 145 RESIDENTS AND 567 NON-RESIDENTS. AMONG THE RESIDENTS, 55 WERE CHILDREN, AND THE SHELTER PROVIDED A TOTAL OF 3,365 BED NIGHTS. AT THE ALEX & BRANDON CHILD SAFETY CENTER, WE SERVED CLIENTS FROM 15 DIFFERENT COUNTIES, FACILITATING 1,081 VISITS, 310 EXCHANGES, AND COMPLETING 226 NEW INTAKES. ADDITIONALLY, MMWC/RSA CONDUCTED 348 GROUPS AND REACHED 5,556 INDIVIDUALS THROUGH PRESENTATIONS AND GROUP SESSIONS, FURTHERING OUR MISSION TO CREATE SAFER, HEALTHIER COMMUNITIES.
