At Miriam learning is intentional collaborative and personalized designed to meet the unique social emotional physical and academic needs of each student. 168 Students served.

Miriam Operates a Learning Center to provide specialized services for students ages 2-18 with learning differences. Services offered include IQ and psychological testing tutoring counseling in-school supports St. Louis Charter and Private Schools behavior support occupational music and speech therapy. Specialized Services are provided to over 1,550 children annually.
