Delta Center for Independent Living is a non-profit organization which exists to support people with disabilities to live as independently as possible in the community. Our coverage area includes St. Charles, Lincoln, and Warren Counties. We are one of twenty-two centers in Missouri. Centers for Independent Living arose from the disability rights movement in the early 1970s. Communities were not accessible and supports to assist people with remaining in their homes did not exist. The disability rights movement led to the Rehabilitation Act of 1975 and eventually the Americans with Disabilities Act. Connecting people to community resources through our information and referral services assisted 717 people during the last reporting year. Referrals range from financial assistance to transportation to in-home supports and health care services. There is no end to what people with disabilities will need in the way of community supports to remain independent. Skills training, which can encompass self-advocacy, cooking, budgeting, etc. assisted 86 people over the last year. Peer support services connect people with disabilities with each other in order to create natural support networks of people who have common, shared experiences. Sixteen received peer support services in FY24. Delta Center partners with Missouri Assistive Technology with their TAP program. This provides a free adapted telephone to anyone with a hearing or visual impairment who makes less than \$60,000 per year. Delta Center partners with the Veterans Administration by providing veteran-directed in-home services in Warren, Lincoln, and Montgomery Counties and St. Louis City in Missouri as well as a dozen counties in Illinois. This program continues to grow. Delta Center also provides the financial management service part of the program to Centers for Independent Living in other parts of Missouri which offer the Veteran Program. Delta Center offers an equipment exchange program which provides durable medical equipment to people who otherwise cannot afford them. During this fiscal year, Delta Center received \$161,577 worth of donated items (if they had been purchased new). We recorded those donations at an estimated fair market value when donated of \$24,003. Two hundred forty-four individuals received two hundred sixty-four donated medical and adaptive equipment. Delta Center offers an Aging in Place assessment designed to identify potential risks and barriers to someone wishing to age-in-place at home. The assessment also offers suggestions for supports and resources to mitigate risks as much as possible. Delta Center partners with other social service agencies to address needs in the community such as affordable and accessible housing, transportation, and health care needs. Across all programs, Delta Center provided services during the year to 1,174 people.

III, Delta Center provided financial management services (FMS) to tax-exempt organizations in Missouri and several states by processing payroll, tax, and payments for non-employee goods and services. All services were paid and subsequently billed dollar-for-dollar to the other entities. The amounts paid by Delta Center and subsequently billed to the organizations for which we provide FMS services are considered agency transactions for accounting purposes and are not included in the revenue (Pt. VIII) and expenses (Pt. IX). Delta Center receives administrative fees for the FMS services which are reported in Pt. VIII, line 2. Delta Center also provided similar services to the Veterans Administration. Since the veterans in the program are eligible for all of Delta Centers support services, the revenue and expenses are not considered agency transactions so are included in revenue in Pt. VIII and expenses in Pt. IX.
Other	The number of employees listed on Pt. V, line 2a, as noted in another comment in Schedule O, represents the portion of Delta Centers shared staff full-time equivalents paid by the related organization, Delta Center PAS (PAS) but who worked on Delta Center CILs (CIL) programs. All of the shared staffs W-2s are filed using PAS Federal ID number (FEIN). CIL acts as a payroll fiscal agent for its clients in the Veterans Independence Program (VIP). It files quarterly 941s and related W-2s for clients attendants wages and taxes using CILs Federal ID number 43-1752410. For 2023 CIL filed 439 W-2s using its FEIN for clients attendants in the VIP program. CIL also acts as a payroll fiscal agent for its FMS (Financial Management Services) clients attendants wages and taxes but uses a different CIL FEIN, 86-2213939. For 2023, CIL filed 354 W-2s for FMS clients attendants using this second FEIN. Since the attendants who work for the VIP and FMS clients are not involved in any of Delta Centers activities, their W-2s are not included in the number on Pt. V, line 2a.
Pt VI, Line 15a	In April 2023, Delta Center purchased compensation reviews for all positions. Salaries for all staff, with the exception of the Executive Director, were adjusted so that the combination of salary and benefits was at least at the 75th percentile of similarly-sized non-profits in the area.
Pt VI, Line 15b	The compensation review for the Executive Director is provided by the Boards executive committee which reviews performance yearly and determines how to adjust the compensation for that position.
