EACH DIRECTOR MUST ABSTAIN FROM BOTH DELIBERATION AND VOTING ON ANY DECISION IN WHICH A CONFLICT OF INTEREST MIGHT PROVIDE MATERIAL FINANCIAL BENEFIT TO THAT DIRECTOR OR A MEMBER OF THEIR IMMEDIATE FAMILY. FURTHER, AT THE BEGINNING OF EACH BOARD MEETING, THE CHAIR OR MEETING FACILITATOR WILL ASK IF ANY DIRECTOR HAS A CONFLICT OF INTEREST TO DECLARE REGARDING ANY ITEM ON THE MEETING AGENDA. IF SUCH CONFLICT IS DECLARED, AND RISES TO THE LEVEL OF MATERIAL FINANCIAL BENEFIT, THE DIRECTOR WILL THEN ABSTAIN FROM BOTH DELIBERATION AND VOTING ON THAT ITEM. IF, DURING THE MEETING A DIRECTOR BECOMES AWARE OF A CONFLICT OR POTENTIAL CONFLICT WITH AN ITEM ON THE AGENDA, AND THAT ITEM RISES TO THE LEVEL OF MATERIAL FINANCIAL BENEFIT, THE DIRECTOR MUST THEN DECLARE THE CONFLICT OR POTENTIAL CONFLICT AND RECUSE THEMSELVES FROM BOTH DELIBERATION AND VOTING ON THAT ITEM. FINALLY, IF A BOARD MEMBER IS UNCERTAIN WHETHER THEY HAVE A CONFLICT OR WHETHER THE CONFLICT RISES TO THE LEVEL OF MATERIAL FINANCIAL BENEFIT, THE CHAIR OF THE BOARD IS EMPOWERED TO MAKE THAT DETERMINATION.
