VOLCKER, HAS MADE OUTSTANDING CONTRIBUTIONS TO RESPONSIBLE CONDUCT IN PUBLIC SERVICE.WITH THE AIM OF SHARING MR. VOLCKER'S LEGACY WITH RISING LEADERS WHILE ALSO SUPPORTING THEIR EXPLORATION OF PUBLIC SERVICE CAREERS, THE ALLIANCE ADMINISTERS THE PAUL A. VOLCKER GOVERNMENT INTERNSHIP AWARD. STUDENTS INTERNING WITH STATE, LOCAL, OR FEDERAL GOVERNMENT ARE ELIGIBLE TO RECEIVE A \$3,000 STIPEND THROUGH THIS PROGRAM. OUR TEAM MANAGES PROMOTION, APPLICATION, AND SELECTION ON A ROLLING BASIS.
