Since 2013, the organization has supported more than 200 social entrepreneurs in more than 60 countries. These entrepreneurs have accelerated the growth of their enterprises, generating more than 3,700 jobs, fundraising more than USD\$ 133mn in capital for their ventures, and impacting positively more than 11 million lives.
