THE MEDICAL ADVISORY BOARD (MAB) INCLUDES RENOWNED EXPERTS ON AUTOIMMUNE ENCEPHALITIS (AE) FROM A VARIETY OF KEY DISCIPLINES - NEUROLOGY, RHEUMATOLOGY, AND PSYCHIATRY AND FOCUSES SPECIFICALLY ON CLINICAL CARE AND RESEARCH EFFORTS TO THE AE COMMUNITY. IN ADDITION TO THE MAB, THE AEA'S CLINICIANS NETWORK CONTINUES TO BE A PREMIER SOURCE WORLDWIDE FOR PATIENTS AND CAREGIVERS SEEKING PHYSICIANS WHO HAVE EXPERIENCE TREATING AE. THE PHYSICIANS IN OUR CLINICIANS NETWORK INCLUDE EXPERTS IN THE FIELD OF AUTOIMMUNE ENCEPHALITIS, AND FREQUENTLY PARTICIPATE IN RESEARCH, CONDUCT CLINICAL TRIAL STUDIES, AND SPEAK IN NATIONAL FORUMS ABOUT THIS RARE DISEASE. THE NETWORK IS THE LARGEST NATIONAL REGISTRY OF PHYSICIANS TREATING AE - A TOTAL OF 380 CLINICIANS PARTICIPATING BY 2024 YEAR END. LED BY THE CLINICAL CARE AND EDUCATION SUBCOMMITTEE OF THE AEA MAB, THE AEA CREATED A NEW AND UNIQUE LEARNING OPPORTUNITY FOR MEMBERS OF OUR CLINICIANS NETWORK, MEDICAL ADVISORY BOARD AND NEUROIMMUNOLOGY FELLOWSHIP PROGRAMS DURING THE 2024 FISCAL YEAR. THE AEA PROVIDER EDUCATION SERIES IS A DYNAMIC SESSION INCLUDING AN ENGAGING DIDACTIC PRESENTATION AND INTERACTIVE DISCUSSION. VOLUNTEER PRESENTERS ARE EXPERTS IN THE FIELD OF AE. THE HOUR IS DEEP DIVE INTO EXPERT KNOWLEDGE AND EXPERIENCE IN THE FIELD OF AUTOIMMUNE ENCEPHALITIS AND PROVIDES THE OPPORTUNITY TO CONNECT WITH FELLOW PROFESSIONALS, SHARE INSIGHTS, AND LEARN FROM REAL-LIFE CASES. IT IS AN EXCELLENT OPPORTUNITY TO ENHANCE KNOWLEDGE, NETWORK WITH LIKE-MINDED INDIVIDUALS AND BUILD A STRONGER AE COMMUNITY OF MEDICAL EXPERTS. WHILE THIS IS A PROVIDER ONLY SESSION, ALLOWING THE COMPLETE COMPLICATED NATURE OF THESE CONDITIONS TO BE FULLY DISCUSSED, THE DIDACTIC PORTION IS RECORDED AND SHARED ON THE AEA WEBSITE FOR THE ENTIRE AEA COMMUNITY TO MEET DOCTORS AND LEARN THE MOST CURRENT AE INFORMATION. THE EVENING ALLOWED 126 ATTENDEES FROM 13 COUNTRIES TO LEARN FROM EACH OTHER AND CREATE NEW RELATIONSHIPS.
