THE DETROIT CREATIVITY PROJECT (DCP) DELIVERS MOST PROGRAM SERVICES UNDER THE IMPROV PROJECT. THE IMPROV PROJECT PROVIDES YEAR-ROUND PROGRAMS FOR DETROIT-AREA YOUTH, EDUCATORS, AND NONPROFIT LEADERS. PROGRAMS INCLUDE WORKSHOPS, SEMESTER-LONG COURSES, AND IMPROV-INTEGRATED CLASSES IN SOCIAL/EMOTIONAL LEARNING, AND ENGLISH LANGUAGE ARTS. THE YOUTH SERVED REPRESENT DIVERSE ETHNIC AND CULTURAL GROUPS FROM THE METRO DETROIT AREA. MOST ARE CONSIDERED ECONOMICALLY DISADVANTAGED BY FEDERAL POVERTY MEASURES. THE MAJORITY OF THE DCP'S PROGRAMS ARE OFFERED AT NO CHARGE. THERE WAS A SMALL PORTION OF REVENUE ATTRIBUTED TO PAID PROGRAMS IN 2024.
