THE MIAMI DIAPER BANK MISSION IS TO COLLECT AND DISTRIBUTE DIAPERS AND OTHER DIAPER RELATED PRODUCTS TO LOW-INCOME FAMILIES AND THEIR CHILDREN, WHILE ALSO RAISING AWARENESS ABOUT THE NEED FOR DIAPER DONATIONS IN THE SOUTH FLORIDA AREA. THE AGENCY DISTRIBUTED OVER 10.5 MILLION DIAPERS SINCE INCEPTION AND SERVICED OVER 200,000 CHILDREN. IN ADDITION, DURING 2024, THE AGENCY WERE ALSO ABLE TO DELIVER 1,589,467 DIAPERS TO 31,693 CHILDREN IN NEED.
