In 2024, the Palestinian American Community Center (PACC) uplifted the community through vital cultural, educational, and civic programming. Highlights included hosting its largest-ever national conference, The Future is Palestine, with over 250 attendees; organizing Palestine Day on Palestine Way, which drew 10,000+ participants; and leading Palestine Week and a Community Healing event. PACC was featured in a national PBS documentary and helped displaced Gazan students resettle in the U.S. Over 300 families regularly participated in PACCs programs, and civic engagement efforts focused on voter education and registration.
