IN 2024, WE CONTINUED OUR WORK PROVIDING TECHNICAL ASSISTANCE TO SMALL BUSINESSES AND SUPPORT FOR COOPERATIVES-WHILE ALSO LAUNCHING NEW TRAININGS FOR ENTREPRENEURS.AT ACER, WE CONNECT BUSINESS OWNERS TO EXPERTS, AT NO COST TO THEM, TO SUPPORT AND COACH THEM THROUGH A WIDE RANGE OF SERVICES AND, IN 2024, WE PROVIDED SERVICES TO 146 BUSINESSES. IN ADDITION, THE TECHNICAL ASSISTANCE PROGRAM CONNECTED BUSINESS OWNERS TO OVER \$700,000 IN CAPITAL. WE ALSO ENGAGED IN WORKFORCE DEVELOPMENT, PROVIDING 227 CERTIFIED NURSING ASSISTANT TRAINING SCHOLARSHIPS AND SUPPORTING EIGHT STUDENTS AT BROOKLYN CENTER COMMUNITY SCHOOLS WITH YOUTH ENTREPRENEURSHIP CLASSES.ACER'S BUSINESS OPPORTUNITY HUB LAUNCHED TWO DISTINCTIVE PROGRAMS IN 2024 TO EMPOWER ENTREPRENEURS WITH THE NECESSARY SKILLS, INSIGHTS, AND TOOLS TO TRANSFORM THEIR IDEAS INTO ACTIONABLE BUSINESS VENTURES. NEARLY 30 ASPIRING AND CURRENT BUSINESS OWNERS PARTICIPATED IN THE ACER BOOTCAMP AND ACER CORE PROGRAMS, WHICH FOSTERED A COLLABORATIVE ENVIRONMENT FOR PARTICIPANTS TO STRATEGIZE, PROBLEM-SOLVE, AND APPLY BUSINESS BASICS EFFECTIVELY.SOCIAL JUSTICE: HOUSING JUSTICE - AT ACER, WE BELIEVE THAT SAFE, STABLE, AND DIGNIFIED HOUSING IS A FUNDAMENTAL HUMAN NEED - AND A BASIC HUMAN RIGHT THAT HAS BEEN DENIED TO MANY BIPOC FAMILIES AND MEMBERS OF THE AFRICAN DIASPORA IN THE NORTHWEST SUBURBS. WE WORK DIRECTLY ALONGSIDE RENTERS AND PARTNER WITH FELLOW HOUSING JUSTICE ADVOCATES TO HOLD LANDLORDS ACCOUNTABLE AND ADVANCE POLICIES THAT INCREASE TENANT POWER.IN 2024, WE SUPPORTED THE POWERFUL RESIDENTS AT SANDER POINT IN ADDRESSING CONCERNS WITH THEIR HOUSING. ALONG WITH THEIR TENANT COUNCIL PRESIDENT, ACER CO-FACILITATED SESSIONS TO SHARE KNOWLEDGE ON ORGANIZING, LETTER CAMPAIGNING, POWER MAPPING AND MORE. WE ALSO SECURED A MAJOR WIN AT THE STATE LEGISLATURE, WORKING WITH THE EQUITY IN PLACE COALITION TO PASS A STATEWIDE TENANTS RIGHT TO ORGANIZE THAT WILL PROVIDE GUARANTEES TO TENANTS TO COME TOGETHER, RAISE THEIR CONCERNS, AND DEFEND THEIR RIGHT TO DIGNIFIES, WELL-MAINTAINED HOUSING WITHOUT FACING RETALIATION AND DISPLACEMENT.SOCIAL JUSTICE: CIVIL ENGAGEMENT - AT ACER, WE ELEVATE THE VOICES OF OUR COMMUNITY MEMBERS AND BUILD BRIDGES BETWEEN RESIDENTS AND DECISION-MAKERS SO THAT OUR KNOWLEDGE AND EXPERTISE DRIVES THE POLICIES THAT SHAPE OUR COMMUNITIES. FROM GOING TO THE BALLOT BOX TO BEING ENGAGED IN LOCAL INFRASTRUCTURE PROJECTS, WE ENCOURAGE BIPOC RESIDENTS AND MEMBERS OF THE AFRICAN DIASPORA TO PARTICIPATE AT THE LOCAL, STATE, AND FEDERAL LEVELS.IN 2024, WE CONTINUED TO BRING COMMUNITY MEMBERS TOGETHER THROUGH ENGAGING AND EDUCATIONAL EVENTS, LIKE THE SHINGLE CREEK FAIR. BUT WE WERE ALSO TIRELESSLY FOCUSED ON ENSURING THAT OUR COMMUNITY IS INFORMED ABOUT THEIR VOTING RIGHTS, AND EMPOWERED TO MAKE THEIR VOICES HEARD AT THE POLLS. THE CRITICAL SUPPORT AND COMMUNITY LEADERSHIP OF 15 VOTER ENGAGEMENT AMBASSADORS CONTRIBUTED TO THE 980 HOURS ACER DEDICATED TO KNOCKING MORE THEN 3,155 DOORS, MAKING MORE THAN 22,000 PHONE CALLS AND FOLLOWING 726 INDIVIDUALS THROUGH THEIR VOTING JOURNEY.SOCIAL JUSTICE: HEALTH EQUITY - AT ACER, OUR PRIMARY FOCUS IS TO ORGANIZE OUR COMMUNITY TO ADVOCATE FOR ADDRESSING SOCIAL DETERMINANTS OF HEALTH AND REDUCE HEALTH DISPARITIES IN OUR COMMUNITY. THROUGH PARTNERSHIPS AND ENGAGEMENT WITH COMMUNITY MEMBERS, OUR TEAM AIMS TO ADDRESS THE ISSUES THAT CAUSE DETRIMENTAL HEALTH OUTCOMES FOR BIPOC COMMUNITIES IN THE NORTHWEST SUBURBS.IN 2024, WHILE MUCH OF THE ATTENTION WAS DIRECTED TOWARDS HELPING THE COMMUNITY MANAGE THE EFFECTS OF COVID-19 ON THEIR SOCIAL AND ENVIRONMENTAL HEALTH, ACER REMAINED COMMITTED TO SUPPORTING VACCINATION AND TESTING INITIATIVES.
