This progress reflects our persistent focus on increasing operator capacity and improving our technology to connect more people with the support they need. We also completed two training cohorts of volunteer operators, expanding our team of empathetic, peer-based supporters. These operators undergo comprehensive training to provide compassionate and understanding support grounded in shared experience and identity.
