By developing leaders, leveraging cultural organizing, and uniting our community's collective power across generations, we aim to dismantle systemic injustice and end racial inequity for all. Founded in 2005 by the late Harry Belafonte, The Gathering continues his legacy of using culture, organizing, and leadership development to build a more just and equitable world.

Youth Programming and Initiatives (Youth Organizers United YOU Program) The YOU Program continued to foster youth leadership by providing mentorship, training, and organizing opportunities to more than 200 students across five high schools in Oxnard, California. Through a series of 20 workshops and leadership sessions, youth organizers developed campaigns, learned advocacy skills, and helped shape policy priorities. The Youth Policy Roundtable produced a Youth Agenda addressing social, economic, and environmental challenges. Community Engagement and EventsThe Gathering organized numerous community events, including the MLK Freedom and Unity Weekend in Oxnard, which brought together activists and residents to honor Dr. Kings legacy through action and dialogue. Additional events included the Stockton Healing Circles, which supported 150 participants in processing trauma and building community resilience, and the Stockton Backyard BBQ, which provided free food, music, and resources for local youth and families. The organization also held Youth Justice Month activities and the Youth Justice Action Month Resource Fair in partnership with Ventura County agencies. Cultural and Policy Advocacy InitiativesThe Gathering continued its cultural organizing and advocacy through its Radical Readz Live events in New York, Oxnard, and Stockton, featuring authors and thought leaders such as Brea Baker and Dr. Jamila T. Davis. These events fostered community conversations about justice, land ownership, and collective healing. The organization also advanced policy priorities through campaigns such as #Right2RemainSilent, Close Rikers, and End Qualified Immunity Advocacy Day, mobilizing hundreds of advocates across New York. Partnerships with Christian Louboutin, Agency Footwear, and other brands elevated awareness and generated support for the mission.
