Our tax preparer initially attempted to e-file this return on November 13, 2025 and the return was rejected. The rejection was apparently a function of the IRS expecting RISE to file IRS Form 990-PF instead of IRS Form 990, even though RISE had timely filed IRS Form 8940 at the conclusion of the 60-month termination period and received confirmation that it was now classified as a public charity and should file IRS Form 990. Our tax preparer called the e-file help desk on November 14, 2025 and a support case was created. Our tax preparer diligently followed up on the support case between November 14 and December 16, on which date they were notified that the issue was resolved and the return could now be e-filed. The return has now been e-filed and we respectfully request that any penalty for late filing be waived or abated.
