	Advocates for Immigrant Rights and Reconciliation (AIRR) recognizes and works to keep families together and end the humanitarian crisis our immigrant community is facing. We believe that all people, no matter where they were born, deserve a chance at a safe and dignified life. AIRR is committed to empower and uplift the voices of the immigrant community and provide them with the tools they need to better protect themselves and their families. In 2024, AIRR expanded programs and partnerships, reaching more than 800 participants through Know Your Rights, Immigration 101, and Accompaniment trainings. The organization also hosted two asylum clinics providing free legal consultations and surveyed over 200 community members to assess immigrant needs. AIRR led multiple advocacy campaigns, including the Safe & Welcoming and Language Access initiatives in both states, helping to defeat 20 anti-immigrant bills and contributing to the creation of the Language Access Office of Kansas City, Missouri. The organization also hosted advocacy days and community forums to elevate immigrant voices. Through nonpartisan voter engagement, AIRR conducted four phone banks, distributed bilingual voter materials, and reached over 53,000 people online resulting in 831 pledges to vote. AIRR's 2024 accomplishments strengthened immigrant leadership, expanded access to justice, and fostered more inclusive communities across Kansas and Missouri.
