Animal Rescue and Providing Care: Luvin Arms provides caregiving staff, veterinary and medical costs, medical supplies, and food/shelter for all animals at the sanctuary. Emergency expenses for both small and large rescue animals, transportation, and short- and long-term animal housing are also offered. Residents at Luvin Arms learn fun and engaging activities such as name recognition, target touching, spinning in circles, and color differentiation. Clicker Play is a tool that creates a common language between animals and humans through rewarding cooperative behaviors with positive reinforcement. These activities provide the mental stimulation that these incredibly intelligent beings need and deserve to live a fulfilling life.
