THE MARKET, A FOOD PANTRY, PROVIDED 19,535 IN-PERSON SHOPPING VISITS DURING THE YEAR. A HOME DELIVERY SERVICE PROVIDED 2,528 HOME DELIVERIES TO ABOUT 100 FAMILIES. THE VACATION & SUMMER LUNCH PROGRAMS PROVIDED 1) SIX WEEKS OF GROCERY SUPPORT TO 76 FAMILIES IN JULY AND AUGUST, 2023, 2) GROCERY SUPPORT TO 39 FAMILIES DURING FEBRUARY, 2024 SCHOOL VACATION, AND 3) GROCERY SUPPORT TO 64 FAMILIES DURING THE APRIL, 2024 SCHOOL VACATION. SNACK PROGRAM: A-EATS PROVIDED 48,042 SNACKS TO ARLINGTON STUDENTS DURING THE 2023-2024 SCHOOL YEAR. PARTNERSHIP PROGRAM - DUE TO THE INCREASED NEED WITHIN THE COMMUNITY AND WITH OTHER ORGANIZATIONS ABLE TO SERVE CERTAIN ARLINGTON AND OTHER AREA RESIDENTS MORE EFFICIENTLY, THE ORGANIZATION PROVIDED 19,100 OF FUNDS FOR THE PURPOSE OF FOOD SECURITY. EATS' FARMERS' MARKET VOUCHER PROGRAM, ALSO KNOWN AS FRESH BUCKS, IS A SNAP MATCH PROGRAM AT THE ARLINGTON FARMERS' MARKET THAT PROVIDES ACCESS TO LOCAL, FRESH FOODS FOR LOW INCOME HOUSEHOLDS.
