Schedule R, Part V, Line 1q	Fair Work Center expenses are allocated to Working Washington as defined in a resource sharing agreement between the two organizations. Examples of expenses that are split are personnel, org-wide contract work, equipment, facilities, office supplies, and similar items. For direct costs such as personnel, it is based on the proportion of salaries Fair Work Center's personnel expended on Working Washington's functions. For overhead costs such as equipment, general office supplies, rent, etc., Fair Work Center and Working Washington are each responsible for 50% of all costs that are jointly applicable to FWC and WW's activities and operations. When expenses are allocated to Working Washington, the payments from Working Washington directly reduce the expenses on the books for Fair Work Center
