Silicon Valley Social Venture Funds (SV2) mission is to unleash the talents and resources of the Silicon Valley community to achieve meaningful social impact. SV2 works to build the organizational capacity of our Nonprofit Grantees and Impact Investees and the philanthropic capacity of our donors (called Partners). SV2 does this through engaged Grantmaking, Impact Investing, and Immersive Learning Sessions in a number of issue areas with funds contributed by our Donor Partners.

Experiential Grantmaking & Impact Investing:SV2 Partners pool their charitable contributions and then work together to identify and select high-potential Grantees and Impact Investees from among local nonprofits and early-stage companies with a social or environmental impact mission. Grantees and Investees receive unrestricted funding in order to scale their ability to achieve their missions and contribute to a Bay Area and world where everyone thrives. In 2023-24, SV2 made four multi-year, general operating support grants to Bay Area nonprofits. Two of these grants were to nonprofits focused on mental health and wellbeing, and two of these grants were to nonprofits focused on using technology for social good. SV2 also conducted its ninth year of impact investing, in which Partners performed due diligence and recommended six mission-driven companies in which SV2 made investments. Data suggests that, as a result of their engagement in SV2 programming, 96% of Partners increased their level of knowledge about local community needs and solutions, 82% of Partners felt an increase in ability to conduct effective due diligence on social impact organizations, and 78% of Partners experienced increased confidence in practicing effective giving.
