ADVOCACY & ORGANIZING: REPRODUCTIVE FREEDOM FOR ALL FOUNDATION AND OUR 4 MILLION MEMBERS IN ALL 50 STATES FIGHT FOR REPRODUCTIVE FREEDOM FOR EVERYBODY. EACH DAY, WE WORK IN COMMUNITY WITH OUR ALLIES AND PARTNERS TO RESTORE, PROTECT, AND EXPAND ACCESS TO ABORTION CARE, BIRTH CONTROL, PAID PARENTAL LEAVE, AND PROTECTIONS FROM PREGNANCY DISCRIMINATION. THE LANDSCAPE FOR REPRODUCTIVE FREEDOM EXPERIENCED A SEISMIC SHIFT IN 2023. IN THE AFTERMATH OF THE SUPREME COURT'S DECISION TO END ROE AND THE CONSTITUTIONAL RIGHT TO ABORTION AS WE KNEW IT-AND STILL KNOW IT TO BE-THIS IS A MOMENT FOR A MASSIVE, DIVERSE GRASSROOTS MOVEMENT, CREATING A WIDER, INCLUSIVE HOME FOR NEWLY ENERGIZED ACTIVISTS. WITH AN EYE TOWARD EQUITY AND INCLUSION, REPRODUCTIVE FREEDOM FOR ALL FOUNDATION IS BUILDING POWER THROUGH OUR ORGANIZING PROGRAM, TRAINING VOLUNTEER LEADERS IN STATES ACROSS THE COUNTRY, AND PROVIDING THEM WITH TOOLS AND RESOURCES TO RECRUIT, TRAIN, AND SUPPORT OTHER VOLUNTEERS IN THEIR COMMUNITIES.
