THE PALESTINE DIABETES INSTITUTE (PDI) WAS ESTABLISHED IN 2009 IN AL-BIREH, PALESTINE. SINCE THEN, THE PDI HAS EXPANDED ITS SERVICES AND OPENED TWO ADDITIONAL CLINICS IN THE CITIES OF NABLUS AND HEBRON, COVERING A WIDER POPULATION IN THE WEST BANK. IT NOW EMPLOYS MORE THAN 20 PALESTINIANS, INCLUDING ENDOCRINOLOGISTS, LAB TECHNICIANS, NURSES, ASSISTANTS, AND OTHERS. THE PDI ADDRESSES THE GROWING DIABETES EPIDEMIC IN PALESTINE THROUGH COMPREHENSIVE TREATMENT AND EDUCATION, AND IS THE FIRST SUCH FACILITY IN PALESTINE.

THE PALESTINE CENTER, THE EDUCATIONAL PROGRAM OF THE JERUSALEM FUND, FOCUSES ON THE IMPLICATIONS OF SPECIFIC U.S. POLICIES WITH REGARD TO PALESTINE, PROVIDING A MUCH-NEEDED PALESTINIAN/ARAB-AMERICAN PERSPECTIVE TO THE POLITICAL, ACADEMIC AND MEDIA ESTABLISHMENTS OF WASHINGTON, D.C. AND THE ARAB WORLD. IT GIVES VOICE TO THE PALESTINIAN NARRATIVE THROUGH POLICY BRIEFINGS, LECTURE SERIES, CONFERENCES, SYMPOSIA, SCHOLARLY RESEARCH PUBLICATIONS AND AN EXTENSIVE RESEARCH LIBRARY. ITS ANNUAL INTERNSHIP PROGRAM, NEARLY TWO DECADES LONG, HAS MORE THAN ONE HUNDRED ALUMNI.
