IN 2024, FAMILY EQUALITY ADVOCATED FOR EQUALITY AT THE STATE AND NATIONAL LEVEL; CONNECTED LGBTQ+ PEOPLE TO ONE ANOTHER, TO VITAL RESOURCES, AND TO THE SUPPORT THAT EVERY FAMILY DESERVES; AND EDUCATED THE PUBLIC TO BUILD MORE INCLUSIVE COMMUNITIES. ADVOCATING FOR EQUALITY IN 2024, FAMILY EQUALITY MADE SIGNIFICANT STRIDES IN PROMOTING EQUALITY FOR FAMILIES NATIONWIDE. AT THE NATIONAL LEVEL, WE GATHERED CRUCIAL DATA ON FAMILIES ACROSS THE RACIAL AND GEOGRAPHIC SPECTRUM THROUGH OUR FAMILY EQUITY JUSTICE SURVEY, WORKED SUCCESSFULLY TO ENSURE THAT ALL STUDENTS FEEL SAFE AND WELCOME IN THE CLASSROOM, AND ADVOCATED FOR BEST PRACTICES IN CHILD WELFARE.
