IN ARIZONA, STAND ADVOCATED FOR THE PASSAGE OF A WAIVER TO THE AGGREGATE EXPENDITURE LIMIT FOR THE FY25 BUDGET, ALLOWING SCHOOL DISTRICTS TO FULLY EXPEND THEIR ALLOCATED FUNDING; INCREASED FUNDING FOR CHILD CARE SUBSIDIES; AND, FOR INCREASED FUNDING FOR DISTRICT-BASED GRANTS FOR NINTH GRADE SUCCESS PROGRAMMING.
