SEE SCHEDULE FAMILY SUPPORT: IN 2024, TLC PROVIDED DIRECT SUPPORT TO 263 FAMILIES. OUR FAMILY SUPPORT SERVICES RECEIVED 606 REFERRALS AND ASSISTED 343 FAMILIES THROUGH RESOURCE NAVIGATION. WE HAVE BEGUN EXPANDING OUR PROGRAMMING TO INCLUDE WEEKLY PARENT GROUPS FOR MOTHERS OF NEWBORNS, TODDLERS, AND PRESCHOOL-AGE CHILDREN. ADDITIONALLY, TLC IS PROMOTING PARENT LEADERSHIP THROUGH A PARENT ADVISORY COUNCIL, WHICH HELPS TO INCORPORATE PARENTS’ VOICES INTO OUR PROGRAMMING. IN 2022, TLC DEVELOPED CLINICAL SUPPORT SERVICES THAT OFFERED CHILD-PARENT PSYCHOTHERAPY, PLAY-BASED THERAPY, AND COGNITIVE BEHAVIORAL THERAPY TO FAMILIES ENROLLED IN OUR FAMILY SUPPORT SERVICES WITH CHILDREN AGED SEVEN YEARS AND YOUNGER. IN 2024, TLC SUPPORTED 56 FAMILIES UTILIZING ONE OF THESE THREE THERAPY MODALITIES.
