OUR LARGEST PROGRAMS ARE: OUR K-12 EDUCATION PROGRAM; HERE COMES SOLAR PROGRAM; GREEN WORKFORCE TRAINING PROGRAM; CLEAN ENERGY COMMUNITIES PROGRAM; AND MANAGEMENT OF STUYVESANT COVE PARK ON THE EAST RIVER AT 23RD STREET IN MANHATTAN. EDUCATION: THROUGH OUR K-12 GREEN DESIGN LAB EDUCATION PROGRAM, WE HAVE REACHED STUDENTS AND TEACHERS IN OVER 1,000 SCHOOLS.
