CENTER FOR GLOBAL LEADERSHIP - INTERNATIONAL VISITOR LEADERSHIP PROGRAM (IVLP) - FOR 65 YEARS MERIDIAN HAS BEEN A PRINCIPAL PARTNER IN IMPLEMENTING THE IVLP, THE U.S. DEPARTMENT OF STATE'S PREMIER PROFESSIONAL EXCHANGE PROGRAM. BETWEEN OCTOBER 1, 2023 - SEPTEMBER 30, 2024, MERIDIAN DEVELOPED IVLP PROJECTS FOR 1,581 EMERGING INTERNATIONAL LEADERS THROUGH 186 PROJECTS. PROGRAM TOPICS RANGED FROM SPACE, U.S. FOREIGN POLICY AND CYBERSECURITY. THESE ENGAGEMENTS OFFERED TIMELY INSIGHTS INTO INVESTMENT CLIMATES, REGULATORY SHIFTS, AND GEOPOLITICAL RISKREINFORCING THE GROWING ROLE OF THE PRIVATE SECTOR IN ADVANCING U.S. GLOBAL LEADERSHIP. A MAJOR MILESTONE WAS THE RELEASE OF THE U.S. COMPETITIVENESS REPORT, HIGHLIGHTING THE CRITICAL INTERSECTION OF DIPLOMACY AND ECONOMIC STRATEGY.
