In 2024, MSI US supported 23.8 million women and girls with their reproductive healthcare across Africa, Asia, and Latin America. MSI-US averted 17.1 million unintended pregnancies and 8.8 million unsafe abortions, and saved the lives of over 38,700 women and girls. MSI-US engages in dynamic fundraising activities to attract support from individuals, family foundations, and estate gifts, in addition to receiving a few larger contributions from professional foundations. We deploy digital marketing, email, and direct mail to build a base of supporters, and currently we have an active file of 5,000+ constituents who engage with MSI-US.

\$82,618,486 million (USD) In 2023, MSI-US excluded a testamentary bequest of \$82,618,486 million (USD) from public support as an "unusual grant." The bequest includes no restriction or limitation on its use. The bequest was unexpected because the individual never notified MSI-US that MSI-US would be the beneficiary of decedent's testamentary estate. Although the decedent contributed a total of \$1.6 million (USD) from 2016 to 2022, the decedent never engaged directly with anyone from MSI-US on the phone or in person. Rather, the decedent at one point requested that they not be contacted in response to a thank-you e-mail sent by MSI-US. The decedent was not an officer, director, employee, or contractor of MSI-US. Furthermore, to MSI-US's best knowledge, the decedent was not related to any current or former MSI-US officers, directors, employees, or contractors. Thus, MSI-US had no reason to expect that it would be the recipient of the remainder of decedent's substantial testamentary estate. The decedent's decision (when living) to make a testamentary bequest to MSI-US, without MSI-US's knowledge, demonstrates that the bequest was made because of MSI-US's publicly supported nature. However, because the large size and the contribution source, including the bequest in public support adversely affects MSI-US's public support percentage in 2023 and would continue to adversely affect MSI-US's public support percentage for the next five years. Accordingly, MSI-US has excluded the bequest from public support as an unusual grant in accordance with Treas. Reg. sec. 1.170A-9(f)(6)(ii).
