THE ALLEGHENY COUNTY PARKS FOUNDATION RECENTLY COMPLETED A VARIETY OF PROJECTS IN THE NINE ALLEGHENY COUNTY PARKS, IN PARTNERSHIP WITH ALLEGHENY COUNTY. THESE INCLUDE THE CLOSE OUT OF THE RESTORATION OF THE CASCADES IN SOUTH PARK AND THE COMPLETION OF PINKERTONS RUN ABANDONED MINE DRAINAGE AND STREAMBANK STABILIZATION PROJECT (PHASE 1). WE ALSO COMPLETED A MAJOR FEASIBILITY STUDY TO CONNECT SOUTH AND WHITE OAK PARKS WITH A 23-MILE TRAIL, ENGAGING SIX COMMUNITIES THROUGH PUBLIC MEETINGS AND SURVEYS TO ENSURE THE PLAN MET LOCAL NEEDS. THE STUDY NOW SERVES AS A BLUEPRINT FOR FUTURE TRAIL DEVELOPMENT AND FUNDRAISING.
