Provided direct financial assistance to 1373 individuals (not unduplicated) individuals for a total of \$250,351. This assistance included utility payments, rent/mortgage payments, and other miscellaneous assistance. Also distributed food and other items to 58,663 individuals (not unduplicated) which had an approximate average wholesale value of \$6,157,072. The items in addition to food was needed clothing, shoes, coats, pet food, baby food, diapers, personal/hygiene products, incontinence supplies and fans.

Ashure has contracted with the Catawba County Department of Social Services to administer the Crisis Intervention Program, and the Low Income Energy Assistance Program, for all Catawba County residents. All applications for assistance are processed by Ashure Ministry case workers. The applications are then forwarded to the County for payment. Through these programs, Ashure Ministry assisted an additional 6,886 (not unduplicated) individuals with financial assistance in the amount of \$785,167
