WHILE OUR VOLUNTEER MEMBERSHIP CONTINUES TO GROW OVER THE PAST YEAR, WE DO NOT HAVE ENOUGH MEMBERS TO MEET THE GROWING NEED FOR PET THERAPY SERVICES IN THE GREATER ATLANTA AREA.
