MATERNAL CHILD HEALTH PROGRAM (MCH) INCLUDES THE ATLANTA HEALTHY START INITIATIVE, WHICH PROVIDES PRENATAL AND POSTPARTUM CASE MANAGEMENT, PERINATAL HOME VISITING, MATERNAL MENTAL HEALTH SERVICES, DOULA SERVICES, BREASTFEEDING AND LACTATION EDUCATION, FATHERHOOD SERVICES, AND RESOURCES TO ADDRESS SOCIAL DETERMINANTS OF HEALTH (SDOH). THIS INITIATIVE SERVES WOMEN FROM PREGNANCY THROUGH 18 MONTHS POSTPARTUM, FATHERS, AND INFANTS.
