SCHOOL PROGRAMS INCLUDE FIELD TRIPS WITH ACTIVITIES THAT ARE CORRELATED TO FLORIDA'S SCIENCE EDUCATION STANDARDS AND VARY BY GRADE LEVEL. IN-SCHOOL PRESENTATIONS ARE PROVIDED PER GRADE LEVEL ON A CLASS BY CLASS BASIS.
