IN FY 2024 MIFA'S two SENIOR PROGRAMS PROMOTED INDEPENDENCE, HEALTH, COMPANIONSHIP, AND DIGNITY THROUGH THESE SERVICES: - MIFA Meals on Wheels served 726,166 meals to 4,122 seniors; of those clients, 2,965 received home-delivered meals and 1,188 were served at congregate sites. Surveyed clients reported the following: 94.47% eat healthier foods as a result of the program, 89.99% believe the program helps them feel better, and 89.55% of home-delivered meal recipients believe the program helps them continue living in their own homes. - The Long-Term Care Ombudsman program's three staff members and seven volunteers completed 308 volunteer hours while providing advocacy for the care and dignity of seniors living in local facilities; they reached 4,964 individuals, including residents and their family members and facility staff members. They handled 492 complaints and opened 269 cases.

MIFA OFFERS A SPECTRUM OF PERSONALIZED INTERVENTIONS DESIGNED TO ADDRESS THE VULNERABILITIES THAT COULD LEAD AN INDIVIDUAL OR FAMILY TO HOMELESSNESS. - Of the 10,290 unduplicated households that requested Emergency Services assistance in FY24, 1,659 (representing 1,909 adults and 1,928 children) received utility, rent, or mortgage assistance. - Emergency Shelter Placement screened 1,452 unduplicated families for service and referred 211 (representing 222 adults and 577 children) to shelters. - The Rapid Rehousing program connected 79 families representing 80 adults and 207 children with permanent, stable housing. - The 24-hour Hotline for Homeless Families screened 6,684 calls from an estimated 4,927 callers representing 5,399 adults and 6,314 children.
