ADVOCACY IN 2024, AI JUSTICE CONTINUED TO LITIGATE SEVERAL IMPORTANT IMPACT CASES. IN THE CONSTITUTIONAL CHALLENGE TO SECTION 10 OF FLORIDA'S INFAMOUS SB 1718 (FWAF V. DESANTIS) PLAINTIFFS MOTION FOR PRELIMINARY INJUNCTION WAS GRANTED IN MAY 2024. AI JUSTICE CONTINUED TO LITIGATE TWO FAMILY SEPARATION CASES (RYMR V. USA AND SEBM V. USA) PRIMARILY UNDER THE FEDERAL TORTS CLAIMS ACT (FTCA). AI JUSTICE WAS ABLE TO SECURE SUCCESSFUL SETTLEMENTS FOR OUR CLIENTS IN BOTH CASES. AN ADDITIONAL FTCA MATTER, CHALLENGING THE MISTREATMENT OF OUR CLIENT BY ICE AND CBP CONTINUED TO MOVE FORWARD (HINESTROZA V. USA). IN AUGUST 2024, THE D.C. CIRCUIT COURT UPHELD A RULE ALLOWING THE LAWFULLY-ADMITTED SPOUSES OF H-1B VISA HOLDERS TO OBTAIN AUTHORIZATION TO WORK WHILE AWAITING LAWFUL PERMANENT RESIDENCY. AI JUSTICE PARTNERED WITH BOIES SCHILLER FLEXNER TO REPRESENT IMMIGRATION VOICE, AS AN INTERVENOR IN SAVEJOBS V. USA, IN ADVOCATING FOR THIS RULE. FINALLY THE TEAM JOINED THE BROWN V. RAMSAY, A LAW SUIT FILED ON BEHALF OF A NATURAL-BORN U.S. CITIZEN WHO WAS UNLAWFULLY DETAINED BY THE MONROE COUNTY SHERIFF BASED ON AN ERRONEOUS ICE DETAINDER, TRANSFERRED TO ICE CUSTODY, AND ALMOST DEPORTED TO JAMAICA BECAUSE OF THE SHERIFF'S IMPROPER COLLABORATION WITH ICE.

WE SERVED 8,371 IMMIGRANTS FROM 82 COUNTRIES, FILING OVER 800 APPLICATIONS BEFORE USCIS AND REPRESENT OVER 400 INDIVIDUALS BEFORE THE EXECUTIVE OFFICE FOR IMMIGRATION REVIEW. OVER 600 SURVIVORS OF DOMESTIC VIOLENCE, CRIME, AND HUMAN TRAFFICKING RECEIVED SERVICES AND WE REPRESENTED 248 CHILD SURVIVORS OF ABUSE, ABANDONMENT, OR NEGLECT, INCLUDING 124 CHILDREN IN FOSTER CARE. WE ALSO PROVIDED ORIENTATION AND ADVICE TO OVER 1,300 ASYLUM SEEKERS. WE PROVIDED OVER 200 KNOW YOUR RIGHTS PRESENTATIONS REACHING OVER 1600 INDIVIDUALS. ADDITIONALLY, WE RECEIVED SUPPORT FROM 22 PRO BONO PARTNERS ON 42 CASES.
