LAW AND POLICY OUTREACH - THE OBJECTIVE OF PERC'S LAW AND POLICY OUTREACH IS TO DISSEMINATE TO TARGETED AUDIENCES THE IDEAS GENERATED BY OUR RESEARCHERS, FELLOWS, VISTING SCHOLARS, AND ENVIROPRENEURS AND EFFORTS OF OUR CONSERVATION INNOVATION LAB. OUR POLICY EFFORTS INCLUDE OUTREACH AT THE FEDERAL LEVEL IN CONGRESS AND THE EXECUTIVE BRANCH, AS WELL AS THE STATE LEVEL.
