ilooklikeLOVE serves the Dallas community and surrounding areas through two signature programs; our Mobile Diaper Pantry and EmpowerU Program for Expecting Mothers. Our Mobile Diaper Pantry distributes diapers, wipes and other baby care essentials to families in need via community-wide diaper distributions, emergency assistance, community partnerships, and disaster recovery efforts. Our EmpowerU Program for Expecting Mothers builds the capacity of expecting single mothers for mental, maternal, financial wellness. Through mentoring, workshops, and cohorts, mothers are equipped for their new beginning through prenatal and postnatal education, life skills development, financial literacy, and workforce preparation.

Immediate relief is provided through diapers and other essentials distributed by our Mobile Diaper Pantry, the first of its kind in North Texas. Diaper Day events serve as our mass distribution channel. 240,202 diapers were distributed to 1,783 families to support the health and well-being of 2,231 children in 2024, including 28 families experiencing domestic violence, recent homelessness, disability of the mother or child, or kinship foster care.

The EmpowerU Program for New Families works with single head of households to build their capacity for mental, maternal, and financial wellness. Life Skills development, financial education and workforce readiness services are provided through cohorts, workshops, and community-wide "Global baby Showers". Expecting cohort participants are assigned a Mommy Mentor to help them navigate and prepare for their new beginnings. 195 families participated in EmpowerU programming, including 8 participants in the EmpowerU/Dallas College Medical Assistant Program, 21 graduates of our Money Camp Cohorts, and 15 active families in the 529K College Savings Plan in partnership with United Way Dollars 4 College Program.
