These initiatives ensured that more community members were prepared to participate in upcoming elections.

Voter Engagement: GAMVP implemented nonpartisan voter engagement strategies to encourage turnout during elections. This included phone and text banking, door-to-door outreach, and Get Out the Vote (GOTV) efforts such as Prayers to the Polls. These activities helped connect community members with accurate voting information and promoted active civic participation.
