IT IS OUR MISSION TO WORK WITH THE COMMUNITIES WE SERVE SO THAT TOGETHER WE CAN COME UP WITH LONG TERM PERMANENT SOLUTIONS THAT IMPROVE THE QUALITY OF LIVES FOR HUMANS AND ANIMALS.

TURTLE MOUNTAIN ANIMAL RESCUE'S MISSION IS TO RESCUE STRAY ANIMALS AND RE-HOME ONES IN NEED WHILE PUTTING INTO PLACE THE NECESSARY SERVICES TO DECREASE ANIMAL OVERPOPULATION. IT IS OUR MISSION TO WORK WITH THE COMMUNITIES WE SERVE SO THAT TOGETHER WE CAN COME UP WITH LONG TERM PERMANENT SOLUTIONS THAT IMPROVE THE QUALITY OF LIVES FOR HUMANS AND ANIMALS. IN 2024, WE TOOK IN 770 ANIMALS, 572 DOGS AND 198 CATS. WE ALSO HAD SEVERAL LITTERS BORN AT THE RESCUE. WE FACILITATED THE ADOPTIONS OF 483 ANIMALS. WE HAVE ALSO PARTNERED WITH SEVERAL OTHER ANIMAL RESCUES TO MOVE ANIMALS TO PLACES THAT DON'T HAVE AS MANY ANIMALS AVAILABLE. TMAR HAS EXPANDED ITS REACH BEYOND OUR ADOPTION AREA OF NORTH DAKOTA AND MINNESOTA BY ORGANIZING ADOPTION ROAD TRIPS RESULTING IN ADOPTIONS IN 16 STATES AND 1 IN CANADA. BY FACILITATING ADOPTIONS OF DOGS AND CATS OUTSIDE OUR REGION, WE'VE NOT ONLY FOUND HOMES FOR THESE ANIMALS BUT ALSO CREATED SPACE TO RESCUE MORE HOMELESS OR INJURED ANIMALS. LAST YEAR, OUR ROAD TRIPS ENABLED 44 ANIMALS TO FIND THEIR FOREVER HOMES, WHILE ALSO PROVIDING A SAFE HAVEN IN OUR RESCUE FOR OTHER ANIMALS. WE ALSO BUILT ON OUR AIR TRANSPORT PROGRAM THROUGH SOUTHWEST AND DELTA AIRLINES ADOPTING 8 ANIMALS IN 4 STATES. WE HELD 4 FREE SPAY / NEUTER / VACCINATION CLINICS IN 2024. WE SPAYED OR NEUTERED 197 DOGS AND 108 CATS. WE ALSO ADMINISTERED 1,232 VACCINES INCLUDING RABIES, PARVO AND DISTEMPER. OUR DONATIONS FOR 2024 WERE UP 16% FROM 2023, ALTHOUGH WE DID DROP DONATIONS FROM FOUNDATIONS DUE TO A QUALIFIED AUDIT IN 2022. WE ALSO ADMINISTER A PET FOOD PANTRY IN PARTNERSHIP THE HUMANE SOCIETY AND CHEWY FOR FAMILIES WHO OTHERWISE MIGHT HAVE HAD TO GIVE UP THEIR PET. OUR CURRENT RESCUE IS ON A RENTED PROPERTY AND IN DECEMBER, WE WERE TOLD THE LAND WOULD BE SOLD. OUR NEW RESCUE BUILDING (IN PROGRESS) WILL NOT HAVE POTABLE WATER FROM THE COUNTY FOR 2-3 YEARS. THIS THREATENED OUR EXISTENCE AS A RESCUE. WE STARTED A CAPITAL CAMPAIGN IN MID DECEMBER 2024 AND WE ARE HOPING TO SECURE THE CURRENT RESCUE BUILDING AND ACREAGE IN THE FIRST QUARTER OF 2025.

WE HELD 5 FREE SPAY / NEUTER / VACCINATION CLINICS IN 2023. WE SPAYED OR NEUTERED 295 DOGS AND 160 CATS. WE ALSO ADMINISTERED 1,232 VACCINES INCLUDING RABIES, PARVO AND DISTEMPER. OUR DONATIONS FOR 2023 WERE UP 31% FROM 2022, ALLOWING US TO RECOVER FROM THE DISTEMPER OUTBREAK, CONTINUE OUR RESCUE CONSTRUCTION AND CURB THE ANIMAL POPULATION. WE ALSO ADMINISTER A PET FOOD PANTRY IN PARTNERSHIP THE HUMANE SOCIETY AND CHEWY FOR FAMILIES WHO OTHERWISE MIGHT HAVE HAD TO GIVE UP THEIR PET. IN THE BUILDING PROJECT, WE HAVE COMPLETED THE GREENHOUSE, AND WE HAVE THE EXTERIORS DONE FOR THE YOUTH CENTER AND MAIN RESCUE. WE COMPLETED THE FIRST PHASE OF SOLAR AND HAVE STARTED ON THE GEOTHERMAL.
